All artists selected are required to provide their own tents **and weights** for their space. If you require electrical, there is an additional cost of \$15.00.

Downtown Booth Participation Rules

1. Space will be provided in area units no less than 10' x 10', only on the streets and designated by the Committee as the site of the Ravenna Creates! Art on Main Art Festival. You cannot go into the street farther than the ten foot limit. Each organization, business, or individual must furnish its own help for construction, manning, and tearing down its booth. Your fee must accompany the application AND THE RELEASE to be confirmed by the Committee. Make checks payable to:
Main Street Ravenna, Inc.
2. Multiple area units purchased by the same participant will be adjacent to each other unless you request otherwise.
3. You will receive your space assignment by June 10th.
4. The Committee provides only the space. You are required to provide your own equipment including, but not limited to, heavy duty 12-gauge or larger drop cords, trash receptacles for your area, water, tables, and chairs.
5. Display booths and equipment can be moved into your designated area after 8:30 am on Saturday, June 22nd in downtown Ravenna. All vehicles must be cleared from the street in front of your area and your booths completed by 10:30 am. You may park your vehicles anywhere there is legal parking in Ravenna. Do not park anywhere that is roped off or barricaded.
6. Check-in at the Information Booth before you proceed to your booth area. The Information Booth is located on the street in front of the Portage County Court House.
7. THE FESTIVAL ENDS AT 5:00 PM AND YOU WILL THEN BE PERMITTED TO BRING YOUR VEHICLES IN THE FESTIVAL AREA TO PACK UP. ALL DISPLAYS, BOOTHS, OR CONCESSIONS CANNOT BE REMOVED BEFORE 5 PM.
8. Extension cords must be outdoor, heavy duty 12 gauge or larger drop cords. Household power strips and extension cords will not be allowed.
9. NO REFUNDS AFTER JUNE 1ST.

Release, Waiver of Liability, and Indemnity Agreement

In consideration of being permitted to participate in the Ravenna Creates! Art on Main and to maintain a booth or activity therein, on Saturday, June 22nd, 2019, the Undersigned, for it, its representatives, heirs, successors, and assigns:

- 1) HEREBY RELEASES, WAIVES, DISCHARGES, AND COVENANTS NOT TO SUE RAVENNA CREATES! ART ON MAIN organization, Main Street Ravenna, Inc., their representatives, heirs, successors, and assigns (hereinafter referred to as Indemnitees) from any claims or demands due to any loss or damage on account of any injury to person or property caused by the negligence of Indemnitee while the Undersigned is participating in the Ravenna Creates! Art on Main in any manner.

- 2) HEREBY AGREES TO INDEMNIFY, SAVE AND HOLD HARMLESS THE INDEMNITEES from any claims or demands due to any loss or damage on account of any injury to person or property caused by the negligence of the Undersigned or its agents while the Undersigned is participating in, setting up, working, observing or otherwise in the Ravenna Creates! Art on Main.

- 3) HEREBY ASSUMES FULL RESPONSIBILITY FOR AND RISK OF BODILY INJURY, DEATH, OR PROPERTY DAMAGE due to the negligence of the Indemnitees or otherwise while participating in the Ravenna Creates! Art on Main and while setting up the booths, working, observing, or otherwise participating in such event.

Each of the Undersigned further expressly agrees that the foregoing Release, Waiver of Liability, and Indemnity Agreement is intended to be as broad and inclusive as is permitted by the law of the State of Ohio, and that the balance shall, notwithstanding, continue in full force and effect. THE UNDERSIGNED HAS READ AND VOLUNTARILY SIGNS THE RELEASE, WAIVER OF LIABILITY, AND INDEMNITY AGREEMENT, and further agrees that no oral representation, statements, or inducements apart from the foregoing written agreement have been made.
