Important Dates for 2021 ONLY

- **June 1, 2021:** Discounted Application Fee Deadline
- **July 15, 2021:** Application Deadline. Applications submitted after this date will be considered by categorical need and space availability.
- **July 30, 2021:** Final date Artists will be Notified of Decision to participate.
- **July 30, 2021:** Complete set-up instructions and event details emailed to artist
- **August 7, 2021:** Art on Main event from 11:00am-7pm

Information and Rules:

Conditions of Entry and Artwork Requirements

- Applicants must submit the Application, Release along with at least three original images of your artwork to the above address or emailed to info@mainstreetravenna.org.
Payment can be made through the Main Street Ravenna website at www.mainstreetravenna.org/artonmain
- Applicants will be given priority consideration in booth placement by date of receipt of Application, Release, Photos and payment in full.
- **All artwork for sale is to be original work created by the artist.**
- All artists selected are required to provide tents **with weights** for their space. If you require electricity, there is an additional cost of \$15.00.

Fees

- **Booth Fee:** \$70
- There is an **additional \$15 fee** for the use of electricity
- A \$10 dollar discount will be applied to all applications submitted by June 1, 2021.
- All Artist application fees are non-refundable, regardless of acceptance into the show unless cancelled due to the Covid-19 Pandemic only.



Booth Participation Rules

1. Please check-in at the Information Booth before you proceed to your booth area. The Main Street Ravenna Information Booth is located on the corner of South Parkway and Main Street under a red tent.
2. Space will be provided in area units no less than 10' x 10', only in the area designated by the Committee as the site of Art on Main. Vendors are required to provide their own equipment including, but not limited to, heavy-duty 12-gauge or larger drop cords, trash receptacles for your area, water, tables, and chairs.
3. Each vendor must furnish its own help for construction, manning, and tear down of booths.
4. Multiple area units purchased by the same participant will be adjacent to each other unless requested otherwise.
5. Display booths and equipment can be moved into your designated area after 8:00 am on Saturday, August 7. All vehicles must be cleared from the street in front of your area and your booths completed by 10:30 am! You may park your vehicles anywhere there is legal parking in Ravenna. Do not park anywhere that is roped off or barricaded.
6. **Art on Main ends at 7:00 pm. You will then be permitted to bring your vehicles into the festival area to pack up. All displays, booths, or concessions cannot be removed before 7 pm.**
7. Extension cords must be outdoor, heavy-duty 12 gauge or larger drop cords. Household power strips and extension cords will not be permitted.

Release, Waiver of Liability, and Indemnity Agreement

In consideration of being permitted to participate in Art on Main and to maintain a booth or activity therein, on Saturday, August 7, 2021, the Undersigned, for it, its representatives, heirs, successors, and assigns:

1) HEREBY RELEASES, WAIVES, DISCHARGES, AND COVENANTS NOT TO SUE THE ART ON MAIN organization, Main Street Ravenna, Inc., their representatives, heirs, successors, and assigns (hereinafter referred to as Indemnitees) from any claims or demands due to any loss or damage on account of any injury to person or property caused by the negligence of Indemnatee while the Undersigned is participating in Art on Main in any manner.

2) HEREBY AGREES TO INDEMNIFY, SAVE AND HOLD HARMLESS THE INDEMNITEES from any claims or demands due to any loss or damage on account of any injury to person or property caused by the negligence of the Undersigned or its agents while the Undersigned is participating in, setting up, working, observing or otherwise in Art on Main.

3) HEREBY ASSUMES FULL RESPONSIBILITY FOR AND RISK OF BODILY INJURY, DEATH, OR PROPERTY DAMAGE due to the negligence of the Indemnitees or otherwise while participating in Art on Main and while setting up the booths, working, observing, or otherwise participating in such event.

4) I UNDERSTAND THAT: Main Street Ravenna has the right and responsibility to cancel the Art on Main event due to the increase in Covid-19 pandemic cases in accordance with State of Ohio mandates and will notify all applicants in a timely manner regarding the cancellation up to 2 weeks in advance of the event at the latest.

Each of the Undersigned further expressly agrees that the foregoing Release, Waiver of Liability, and Indemnity Agreement is intended to be as broad and inclusive as is permitted by the law of the State of Ohio and that the balance shall, notwithstanding, continue in full force and effect. THE UNDERSIGNED HAS READ AND VOLUNTARILY SIGNS THE RELEASE, WAIVER OF LIABILITY, AND INDEMNITY AGREEMENT, and further agrees that no oral representation, statements, or inducements apart from the foregoing written agreement have been made.
